RESOLUTION NO. 2015-08

AMENDMENT TO THE BUDGET FOR THE FISCAL YEAR 2015,
BEGINNING JULY 1, 2014 AND ENDING JUNE 30, 2015

WHEREAS, the Albuquerque Housing Authority (AHA), is a New Mexico Public Body Corporate, who has passed and adopted Housing Resolution 2014-13 (Operating Budget for FY2015), on June 24, 2014, to; and

WHEREAS, the Municipal Housing Law of New Mexico (§3-45-1 NMSA 1978) authorize the Board to adopt an annual budget to appropriate funding for the continued operation of the Albuquerque Housing Authority; and

WHEREAS, the budget amendment findings are administrative only to allocate budget where it is being expensed which allows the financials to be better represented to the AHA Board of Housing Commissioners, the Governing Body of AHA; and

WHEREAS, AHA Board of Housing Commissioners, the Governing Body of AHA finds that it is in the long term best interest of AHA to approve adoption of this Budget Amendment (a copy of the Financial Year 2015 Budget Amendment is attached as Exhibit 1) to better represent the allocated funding for the operation of AHA programs; and

WHEREAS, the budget amendments apply to all AHA programs (e.g. Public Housing, Section 8 Housing Choice Vouchers for rental assistance, and Central Office Cost Center) for the period of Fiscal Year 2015, begins on July 1, 2014 and ends on June 30, 2015; and

WHEREAS, the U.S. Department of Housing and Urban Development (HUD) does not require that AHA submit the Budget Form HUD 52574 for an administrative amendment that does not introduce new funding or new expenditures as this has a “net zero” effect to the budget and all funding sources; and,

NOW, THEREFORE, BE IT RESOLVED BY THE AHA BOARD OF HOUSING COMMISSIONERS that the proposed Budget Amendment for Financial Year 2015 is hereby approved.
