RESOLUTION NO. 2022-06

**APPROPRIATING FUNDS FOR THE AHA FOR FINANCIAL YEAR 2023,  
BEGINNING JULY 1, 2022 AND ENDING JUNE 30, 2023**

**WHEREAS**, the City Council, the Governing Body of the City of Albuquerque, a New Mexico Municipal Corporation, passed and adopted City Resolution 2010-97 (Enactment # R-2010-145), on December 6, 2010, to establish a Board of Housing Commissioners to govern the Albuquerque Housing Authority (AHA), and to make AHA a Public Body Corporate; and

**WHEREAS**, Bill no. R-2010-97, was signed and approved on December 22, 2010, enacting it as the Municipal Housing Policy of the City of Albuquerque, pursuant to the City’s delegated powers from the State, under the Municipal Housing Law of New Mexico (§3-45-1 NMSA 1978); and

**WHEREAS**, the Municipal Housing Law of New Mexico (§3-45-1 NMSA 1978) and City of Albuquerque Resolution 2010-97, both authorize the Board to adopt an annual budget to appropriate funding for the continued operation of the Albuquerque Housing Authority; and

**WHEREAS**, the AHA Board of Housing Commissioners, the Governing Body of AHA, finds that it is in the long term best interest of AHA to approve adoption of this Budget (a copy of the Financial Year 2023 Budget is attached as Exhibit 1) to appropriate continued funding for the operation of AHA programs; and

**WHEREAS**, Fiscal Year 2023, begins on July 1, 2022 and ends on June 30, 2023; and

**WHEREAS**, the program budgets have been prepared using current and previous year data; and

**WHEREAS**, these budgets apply to many AHA programs (e.g. Public Housing, Rental Assistance Demonstration (RAD), Section 8 Housing Choice Vouchers for rental assistance, and other programs); and

**WHEREAS**, the U.S. Department of Housing and Urban Development (HUD) requires that AHA submit the Public Housing Program budget to the HUD Field Office for review each year and Form HUD 52574 must be signed by the AHA Board Chairperson (or her designee) and submitted with the Budget to HUD; and,

**NOW, THEREFORE, BE IT RESOLVED BY THE AHA BOARD OF HOUSING COMMISSIONERS** that the proposed Budget for Financial Year 2023 is hereby approved. The Board Chairperson (or her designee) is given authorization to sign Form HUD 52574, after which it shall be submitted to the U.S. Department of Housing and Urban Development (HUD) for review (see Form HUD 52574).
