**ADOPTION OF AMENDMENT #11 TO EMPLOYMENT AGREEMENT
BETWEEN AHA AND LINDA BRIDGE**

WHEREAS, the Albuquerque Housing Authority (AHA) has a written Employment Agreement with Executive Director Linda Bridge, which was approved by Resolution 2012-14 and which commenced on December 17, 2012;

WHEREAS the compensation for the Executive Director is determined by the AHA Board of Housing Commissioners, subject to the AHA’s duty to comply with the salary restrictions identified in the federal Fiscal Year 2018 Appropriations Act, and Public and Indian Housing (PIH) Notice 2016-14 (pay shall not exceed Level IV of the Rates of Basic Pay for the Executive Schedule (EX), which is \$183,500 in 2023);

AND WHEREAS the AHA Board of Housing Commissioners has reviewed the performance of Executive Director Linda Bridge.

NOW, THEREFORE, BE IT RESOLVED BY THE AHA BOARD OF HOUSING COMMISSIONERS, the governing body of the AHA that:

1. The Board does hereby adopt Amendment #11 to the Employment Agreement between the AHA and Linda Bridge, which shall increase her annual salary by 3% from \$141,881.26 to \$146,137.70 United States Dollars (USD) commencing September 23, 2023. That 3% salary increase includes: a 3% Cost of Living Adjustment (COLA) that was awarded to all eligible full time regular AHA employees this year who were working for AHA last year.
2. Linda Bridge is also granted a one-time incentive compensation award in the amount of \$10,000 USD of additional compensation, an award based on the achievement of Authority goals and personal performance. The incentive compensation award to be paid in a single payment on September 28, 2023. The award shall not increase Linda Bridge’s annual salary (base pay) listed in paragraph 1.
3. The Chairperson of the Board (or her designee) is authorized to execute Amendment #11 to the Employment Agreement on behalf of the AHA, which is attached as Exhibit A.
